PURPOSE: The TARB will conduct hearings on protests, motions and challenges on the dates listed above. Hearings will be conducted by panels of one or more TARB members. Person's appearing for hearings scheduled for later dates, but not scheduled for the date of appearance, will be heard if there is panel availability, with scheduled hearings taking precedent. Panel hearings are generally open to the public, but they will not involve a quorum of the TARB and will not involve final determinations or actions. A panel date or dates may be canceled due to lack of remaining scheduled protests for that date or partial date. A quorum of the TARB will meet on the date identified below to consider and act on some or all of the following:

- 8. Discussion and possible action on changes to supplemental appraisal records;
- 9. Discussion and possible action on changes or deletions to appraisal roll;
- 10. Discussions and possible action concerning the TARB's procedures, policies, practices, rules and forms;
